For general public knowledge and pursuant the authority vested in Article 27 of Act No. 75 of June 24, 1975, as amended, known as "The Organic Planning Board Act"; Act No. 170 of August 12, 1988, as amended, known as the "Commonwealth of Puerto Rico Uniform Administrative Procedure Act", Act No. 81 of August 30, 1991, as amended, known as "Autonomous Municipalities Act" and Act No. 550 of October 3, 2004, as amended, known as "Land Use Plan Act of the Commonwealth of Puerto Rico", the Puerto Rico Planning Board hereby notifies that will hold public hearings to offer the interested persons, municipalities, governmental agencies, private companies and the public in general the opportunity to express themselves in relation to the matters object of the hearings. DOCUMENTS EXPOSITION


Copy of the proposed Land Use Plan of Puerto Rico which includes the proposed Land Use Classification Map will be available since **January 14, 2015** at the City Halls of the 78 municipalities of Puerto Rico; in the Secretary's Office of the Puerto Rico Planning Board located on the Sixth (6) Floor of the World Plaza Building, #268 Muñoz Rivera Avenue Hato Rey; in the Land Use Subprogram of the Puerto Rico Planning Board, located in the Fifteen (15) Floor, North Building at Roberto Sanchez Vilella Government Center Building, De Diego Avenue corner with Baldorioty De Castro Avenue in Santurce. Also the documents will be available in the Regional Offices of the Permits Management Office (OGPe) in Aguadilla, located at the Government Center Building, on the Ninth (9) Floor, Muñoz Rivera Avenue; in Arecibo, located at Marginal Street, San Patricio Avenue, Road PR-2, km. 80.4, Hato Abajo Ward (in front of Plaza Atlántico Mall); Humacao, located at Road PR-3, South Road, Boulevard Avenue; Ponce, located at the Government Center Building, Third (3) Floor, Hostos Street and Las Americas Avenue #2440 and in San Juan, located at Roberto Sanchez Vilella Gubernamental Center (former Minillas Government Center), North Building, Thirteen (13) Floor, De Diego Avenue corner with Baldorioty De Castro Avenue in Santurce.



INVITATION TO GENERAL PUBLIC

The Puerto Rico Planning Board invites all government agencies, private entities, municipalities and the general public to participate in these public hearings and submit comments and recommendations on these matters.

Section 2.1 of Act No. 170, supra, grants a thirty (30) days period, after the publication of this notice, to submit written comments to: Puerto Rico Planning Board, Secretary's Office, P.O. Box 41119, San Juan, PR 00940-1119. However, in this particular case the Planning Board grants forty-one days to comment these proposals or until February 23, 2015. The Puerto Rico Planning Board will acknowledge receipt of comments received via email in writing within two (2) labor days of receipt, in accordance to section 2.1 of Law 170, supra.
