For general public knowledge and according to Article 27 of Act Number 75 of June 24, 1975, known as "*The Puerto Rico Planning Board Organic Act*", 23 P.R.L.A. sec. 62z and Act Number 170 of August 12, 1988, known as "*The Commonwealth of Puerto Rico Uniform Administrative Procedure Law*", 3 P.R.L.A. sec. 2101 et. seq, and Articles 13.018 of Act Number 81 of August 30, 1991, as amended, known as "*Commonwealth of Puerto Rico Autonomous Municipalities Act*", 21 LPRA., section 4616 and 4618, the Puerto Rico Planning Board notifies that will hold public hearing for the mentioned amendment proposals as follows:

3. We will discuss the amendments proposal of the Calification Map of the Municipality of Guayama. The properties are located at 4 Street #117, Vives Urb.
4. We will discuss the amendment proposal of the Calification Map of the Municipality of Guayanilla. The property is located at state Road#127, Km. 12.6, Magos Ward.

AMENDMENTS PROPOSALS EXHIBIT AND DOCUMENTS AVAILABILITY FOR DISPLAY


Copies of the amendments proposals to the Calification Maps of the Municipalities of Barranquitas, Coamo, Guayama and Guayanilla will be displayed and available on **March 9, 2015**, in Barranquitas, Coamo, Guayama and Guayanilla municipalities City Hall; at the Planning Board Land Use Plan Subprogram, located at the six floor, on 268 Muñoz Rivera Avenue, World Plaza Building, in Hato Rey. Also, will be available at the Permit Management Office (OGPe, for its Spanish acronym), located on the thirteenth (13th) floor of the North Building, Roberto Sánchez Vilella Government Center (former Minillas Government Center) on De Diego Avenue, Stop 22 in San Juan. The amendments proposal will be available on the Permit Management Office, Regional Office of Humacao, #3 Road, Boulevard del Río Bypass, 3th. Floor and the Regional Office of Ponce, Government Center, 2440 Las Américas Avenue.

Any person, organization, citizen, association, institution, corporation that request information about the amendments proposals to be discussed at the scheduled public hearings, can obtain it at the above mentioned locations.

Petitioners, land owners located within the municipal limits mentioned above, government organizations and the general public, are invited to participate at these hearings and submit written comments or recommendations.
